

— The Pioneer Settlement's founder Lura Bell, regarding the Astor Bridge House move quoted in the Daytona Beach News Journal, September 11, 1980.

For more than five decades the Bridge House that was built in 1926 served as the home for men who operated the bridge's swing span to allow river traffic to pass. Originally located on the west bank of the St. John's River the Astor Bridge House evokes much history and mystery. McQueen Johnson, the former ferry operator and the first bridge tender



was on duty in the middle of the bridge when he was shot in the back, and fell across the very middle of the bridge, with his head in Lake County and his feet in Volusia County. Both counties refused to claim jurisdiction and they say that the murder was never solved.

The move of the canopy itself was a major headline maker due to many hurdles like fundraising, time constraints, and it required a very involved massive coordination effort with the State Department of Operations, as well as a team of over 15 construction workers. Once removed the structures were stored on the west side of the bridge awaiting the opening of the newer wider bridge in order to begin its journey to the Pioneer Settlement.

It is appropriate that while the Bridge House had once stood as the entrance way for Volusia and Lake Counties, that for nearly 24 years now it has served as your entrance way to The Pioneer Settlement. The Bridge House makes a perfect welcome center and gift shop and functions as a home for displays and information about the local area and both the River of Lakes Heritage Corridor Scenic Highway and the Florida Black Bear Scenic Byway.

The Bridge House Restoration Fundraiser was launched this past fall with the proceeds of the Silent Auction at the Jamboree being dedicated towards restoration efforts. The restoration plans include foundation stabilization, a new roof, insulation and central heating and air. All of which will help to defray operating costs and enhance the longevity of our very important entrance way to the Settlement.



Due to the vision of Lura Bell and others that supported her vision, the Astor Bridge House was saved from demolition and has been repurposed as a vital and useful resource for the Pioneer Settlement, our visitors and members like you. Any contribution you can make to help us achieve our goal to raise all of the \$40,000.00 needed to complete this project is greatly appreciated.
